LASER TLC TANF Modernization Learning Session

Purpose

As the LASER TLC sites begin to rethink their approach to service delivery and their support for TANF participants and their families, modernizing the safety net is at the forefront of that discussion. Participation in this learning session will allow TLC sites the opportunity to hear about the foundational principles behind TANF modernization, highlighting human services system alignment, and specifically outlining how to operationalize the practice changes incorporated within TANF modernization— harnessing technology and digital solutions; case management strategies; accessing data; creating success indicators; and fully engaging or reengaging clients/constituents in the pandemic-era economy. Additionally, the session also builds upon the OPRE Study highlighted last month. This learning session will provide states, counties, and tribes with an opportunity to learn from a peer about “how” they approached TANF modernization, their challenges, successes, and the lessons learned as they reimagined their approach to human service delivery.

Objectives

By the end of this session, LASER TLC teams will:

1. Understand the core principles fundamental to advancing TANF modernization.
2. Understand how to align services to increase family stabilization and focus on whole family approaches.
3. Learn from a peer about lessons learned in their approach to reimagining TANF given the pandemic, as well as how they are aligning human services to better serve their TANF families.
