What is the Family Self-Sufficiency Program

•Family self-sufficiency (FSS) is a HUD program that encourages communities to develop local strategies to help assisted families obtain employment that will lead to economic independence and self-sufficiency. Public housing agencies (PHAs) work with welfare agencies, schools, businesses, and other local partners to develop a comprehensive program that gives participating FSS family members the skills and experience to enable them to obtain employment that pays a living wage.

## Public Housing Family Self-Sufficiency Program

"Individuals / Families who are living in a housing development owned by a Housing Authority and are participating in the Family Self-Sufficiency Program".

### Who Is Eligible

•Any family receiving Section 8 or Public Housing assistance through a participating public housing agency can participate in the Family Self-Sufficiency Program.



## How to Apply

Submit an application to a PHA in your community and wait for your name to come to the top of the waiting list. Some PHAs do have preferences.

"Must submit an application and the housing assistance must be available".
